 - June, 2019: Online survey of all MAC Members
 - Sept. 2019: Facilitated two MAC member Focus Groups
 - Sept. 30, 2019: MAC Board approved new Strategic Plan
- In 2019 continued promoting the Whistler Community Services Society = Activate and Connect program for 50+ Whistler residents and visitors
- MAC provided presentation to RMOW Council Meeting in Dec. 2019 to encourage their application for the Union of BC Municipalities Age Friendly Community 2020 Grant.

Current membership, approximately: 220 – with Bob Murl noting new member registrations on the MAC Website is generally equal to those who leave MAC

John spoke on behalf of the Committee to openly discuss the challenges of providing value and engagement with members and how to increase MAC membership



As our community came to a complete shut-down of in-person activities, in early 2020 many of our MAC members kept busy in the community, volunteering, spending time with friends and family (online)

Many MAC members created new ways of keeping busy and engaged., with a "constantly moving forward, positive + proactive" theme

Whistler MAC as a 2019 member of Whistler Chamber promoted awareness of our membership, potential for business staffing, advocacy for 55+/seniors

Member – Murray Wood noted that the Whistler Rotary Club has online guest speaker events. For example: Bike Tour reviews & Curator of a Cycling Museum MAC has a new paid Zoom account to work with suggestions to put online events too

Housing Committee Report by: Michael d'Artois

Over the past several years we have created on-going working relationship with: Whistler Housing Authority by advocacy for Whistler MAC members, focused on WHA Rental and Property Purchase - Policies / Procedures.

New WHA Rental Building: 8350 Bear Paw Trail

20 unit apartment building in Rainbow neighbourhood, targeting independent living for Whistler's seniors who are either actively participating in or retired from Whistler's full-time workforce.

This new building contains a mix of 1 bedroom and 2 bedroom units. It has an underground parkade, elevator, and each unit has in-suite laundry.

This building originally opened in December 2019, and as units come available qualified tenants will be selected from the WHA Rental Waitlist, with priority for senior waitlist members over 55 years of age. There are currently (13) suites rented to 55+ residents.

Member - Don Whiteside noted communication complications with WHA property listings and how those procedures should be amended. MAC also sends emails to members to alert them to potential WHA rental + property purchase listings.

John McGregor offered his recent experience and will provide the WHA Checklist which we will post onto the MAC Website resource page and emailed to members in the upcoming Newsletter.
