# MAC Chair Report

Who we are and what we do!

- Vision "a welcoming supportive community where Whistler residents 55+ comfortably age in place and are valued for what they do.
- Mission "Identify Opportunities and advocate for policies and programs that will move our vision into reality."

Our Strategic Plan:

- 5. Create Partnerships

1)Advocate for Seniors Programs and Services:

- Member of Better at Home Advisory Committee with regular monthly meetings.
- Member of Non-profit Network with regular monthly meetings
- Present wish list of needs and wants to RMOW regularly at council meetings
- Talk to council members about seniors when opportunities arise
  - Recent town hall presentations by RMOW from Transportation Advisory
    Group
  - Recent presentation about e-bikes
- Letter of support with Pemberton Seniors and Sea to Sky Community services for Handi-Dart service in Whistler.
  - Met with Jackie Dickinson at WCSS to reinstate weekly senior's programming Now called Activate and Connect.

### 2)Represent our constituency with a Collective Voice

• It means that we want all seniors, living in or visiting Whistler, to speak the same message to other seniors, and to our governing bodies.



- We speak for all the seniors that live in Whistler, not just our members.
- We need to figure out new ways to increase our membership so that when we speak for the ever increasing number of seniors living, playing, working and eventually needing some services here, MAC represents all of those seniors.
- At a recent presentation to council, we used the numbers from the last census Over 2,000 seniors above the age of 55 – as of 2016. We need Whistler's Seniors to understand the value of being a MAC member so that when we go before council – MAC represents a bigger percentage of the actual number of seniors living here which is now more than the 2,000 the census counted in 2016.

# 3)Generate Public Awareness

So what have we done over the past year?

- Workshops in partnership with the Library, CFOW, and Better at Home, Sea to Sky community Services.
  - Estate Planning, or Preparing for your Departure Workshop
  - Brain Matters Workshop
  - Age Friendly Communities Workshop
- Go-Fest presentation of our movie <u>Whistler Wilderness to World Class</u> with the Museum
- Canada Day Parade with a banner for the first time!
- National Seniors' Day October 1<sup>st</sup> with a full afternoon of presentations by many local and Sea to Sky Services in partnership with the Whistler Tennis Club.

### 4)Provide Social Interaction

This past year saw a good number of social events:

- Spring Fling at the Alpine Café
- Go Fest Participation with the Museum
- Canada Day Parade new banner and sign for MAC
- July Bar BQ and Pickle Ball with Whistler Tennis Club
  - Now we have a very active Pickleball group that play every Wednesday at 10:00 a.m.
- Another year of volunteering and hard work for Ironman
- National Seniors Day on October 1<sup>st</sup>
- Got the RMOW to declare October 1st Whistler Senior's Day.
- Fall Masque at the Alpine Café
- Christmas Party and Dance at Nicklaus North
- Christmas Caroling in the Village

# 5)Create Partnerships.

Over the past several years we have created on-going partnerships with:

- Community Foundation of Whistler
- Better at Home, Sea to Sky Community Services
- Whistler Public Library
  - These three partnerships have enabled us to put on our workshops with refreshments at no charge to the seniors in the community

#### New Partnerships this year:

- Spring Creek Elementary School for a reading program
- Whistler Tennis Club enabling us to play Pickleball every Wednesday and have a great location for our annual barbecue and picnic.
- Whistler Community Social Services enabling us to have a regular weekly indoor session in their community room. We have also reinstated (at least once a month) walk and talk followed by coffee.

#### 2018 Summary

- So it would seem that we are doing our best as every year we have been able to see our Vision and Mission clearly and work towards achieving the goals of our Strategic Plan, but what now?
- As we move into 2019, our original MAC mandate of seeking housing for seniors has been fulfilled to the best of our ability, given the RMOW's focus will be on employee housing for the foreseeable future.
- We now need to change that focus more to achieving the goal of making Whistler an Age Friendly Community. Maybe changing our wording from Enabling Seniors to Age in Place to "Making Whistler an Age Friendly Community" might resonate more with our active population and get them on board.
- So, as I leave the Mature Action Community in good hands with several new board members and Kathy White, (Chair-elect) at the helm, there will be changes coming. Other communities have support from local government. For us, there is only MAC. We need all of you to get your non-member friends to understand that we need them to join MAC so that we can all enjoy the benefits of an Age Friendly Community.

### Social Committee Report by: Kathy White



- b) April 17, 2018 Alpine Café MAC Spring Fling: Iain Grunwell coordinated event with Janice. Approx. 20 attendees. Don Crook sang & hats looked lovely. Pictures posted on MAC Facebook page
- c) May 19, 2018 RMOW GoFest: Had approx.. 50 people attend the Wilderness to Worldclass Video at the Whistler Museum and had coffee/tea + snacks
- d) **July 1, 2018** Canada Day Parade MAC volunteers came together to decorate the vehicle donated for use
- e) July 8, 2018 Whistler MAC BBQ held at the Whistler Racket Club starting at 6:00 pm. 30lbs. of chicken from Nesters Market. Bob Calladine manned the barbecue, MAC members and guests had a training and coaching session then played pickle ball on specially painted courts. Music was organized by Iain Grunwell, Janice marinated the chicken and decorated the tables.
- f) July 28, 2018 Ironman Canada MAC volunteers: 8 am to 5 pm, approx.. 30 volunteers hottest day of the year to set up and run "two" beverage + food aid stations at Lost Lake Park
- g) Oct. 1, 2018 National Seniors Day Celebrating Whistler's Active Seniors: Whistler Tennis Club with tradeshow booths, 3 presentations and e-bike draw prize with snacks and refreshments, approx. 80 people attended
- h) October 30, 2018 Alpine Café Fall Masque: 32 MAC members at the Alpine Café and Catering Company. A four- course meal for \$25.00 a person was the price of a ticket and wine was \$20.00 a bottle for red and white was by the glass for \$4.00. Prizes for the best mask. # Housing Committee Report

Last year I told you about the plan to build 20 seniors restricted WHA rental units at 8350 Bear Paw Trail, Rainbow Estates.

This was not in any plans for the future of WHA nor in their attitude towards initiating senior housing in Whistler. It is truly amazing what a \$2 million grant can do to change priorities. BC Housing has added approximately \$1/2 million more to the pot as building costs get higher and higher. The building permit was late from RMOW planning department and last December, the framing crew were fired: all causing the building to fall behind its projected completion date. The contractors, however, are still optimistic about finishing this autumn.

Meanwhile: a brief created by Gary Watson (a founding member of WHA), Gord Leidel (a founding member of MAC), Sue Lawther (past president of MAC), and myself, was presented to the staff of WHA. This brief was our response to an administrative report regarding changes to the Senior's restricted housing purchase guidelines. Presently, there are no specific WHA guidelines for senior's restricted rental housing, only for the general rental wait-list. Our brief tried to ease the process for the staff and at the same time update the qualification point system for both rental and purchasing WHA properties. The result seems to be that there is no Senior's rental wait-list and WHA staff are telling seniors to go on a MAC "list". Guess what? we don't have one either and we certainly have no legitimate power as to who can get on one or has priority in the renting of this new WHA project.



Bob Murl and I are creating an 'unofficial' MAC Senior's rental housing list from a new application-with WHA qualification guidelines-survey. The link to this survey will be sent to all MAC members as soon as it is completed. I would like this 'unofficial list' to be created from this survey/application form that is available only to MAC members. The information we are seeking with this survey must be proven to WHA on the official WHA application when the units become available. There will be an explanation of the priority point system, suite plans, and a request for suite preference that may or may not be granted by WHA. These items will be detailed in the email with the link to the survey when the survey is ready. At this moment there is no knowledge of what the rental fees will be as they are probably determined by the final costs of the building.
